# Registrant Verification

ICANN's latest initiative is now in effect, and aims to bring transparency to public whois data. Find out more here about what registrant verification means for you and how Ascio can help you.

#### What is Registrant Verification?

In 2013, ICANN changed their Registrar Accreditation Agreement (RAA) for all domain registrars. One key initiative within that agreement is Registrant Verification (RV). In short, the fundamental idea of this policy is to improve the reliability of data on domain owners in the Whois. Therefore, as part of the new process, registrants will be required to verify their contact details that they use to register gTLDs & New gTLDs

#### What does this mean if you have an ICANN Accreditation?

Effective immediately, you will have to; for any new registrations, transfer-ins, owner changes, or registrant detail updates; support the new process for all ICANN governed TLDs. The onus will be on you to:

- Validate the contact details provided.
- Verify the email or telephone number of the registrant.

In short, from now on, there is an obligation to send an e-mail with a link to domain registrants, from which the contact details should be verified. Failure to do so will result in the domain being parked.

#### What are the main challenges?

If you are ICANN accredited with thousands of domains, then ICANN's RV policy can be particularly challenging. This new change in protocol can have an immediate effect across several levels:

- Administrative burden: ensuring that all registrant data is verified, and that they update their details in the Whois can be a gigantic task.
- **Unhappy customers:** registrants, who have registered a domain through you, risk that their domain will be parked if they ignore or miss the verification e-mails. Ultimately if their domain goes down, you will be the first point of call.
- **Technological strain**: having the right system in place so that verification e-mails can be sent accurately and automatically can take months to develop as well as substantial resources.
- conditions can lead to your accreditation being suspended, in turn this could lead to a loss of business as you become unable to register certain top level domains.













## RV Timeline Example

To validate registrant contact details, and to ensure ICANN compliancy, three e-mail reminders will be sent out to the domain owner. This can be done by us or by you, and is split across new registrations and updates to existing domain registrations. See more below...

Customer registers for a domain. An e-mail is sent out to the domain owner to be verified. Domain remains parked until verification

DAY 1

Second email verification sent 7 days after initial request.

Domain remains parked until verification

DAY 7

Third email verification sent 7 days after initial request. Domain remains parked until verification

**DAY 15** 

Verification link stays active but after 45 days it will no longer be automatically unparked & delegated to the name servers. Unparking the domain will require a manual NS update

DAY 45 +

New domain registration

Domain is either transferred in, has its e-mail address updated, or has an owner change. An e-mail is sent out to the domain owner to be verified. Domain remains active awaiting verification

DAY 1

Second email verification request sent 7 days after initial request. Domain remains active awaiting verification

DAY 7

Third email verification sent 7 days after initial request. Domain will be parked if not verified after this day **DAY 15** 

Verification link stays active but after 45 days it will no longer be automated on the name server delegation. Unparking the domain will reuire a manual NS update

DAY 45 +

Transfer-ins, owner changes, or registrant details update
